2. The Written Test is of 90 Minutes duration having 75 Objective type questions (OMR valuation).

3. The candidate should report at the venue of the Test with this Admission Ticket **half an hour before the commencement of the Test** for verification of identity. ~~No candidate will be admitted for the Test without producing the Admission Ticket.~~
4. The candidate shall produce a photo affixed Identity Proof such as Driving license/Voters ID/Passport / PAN Card/Aadhaar Card in original to prove his/her identity.
5. The candidate should affix his/her passport size photograph taken within six months, in the space provided on the Admission Ticket. Candidates who report without affixing the photograph will not be allowed to take the test.
6. No candidate will be admitted to the examination hall after the commencement of the Test. The candidate must remain in his/her seat till the answer sheets are collected by the invigilator at the end of the Test. The candidate will not be permitted to leave the hall until the Test is over.
7. **Candidates are prohibited from bringing into the examination hall any book or portion of a book, manuscript, paper or any electronic equipment such as calculator, mobile phone, wireless set, etc. and from communicating with any person inside or outside the examination hall.
