8. **Age relaxation** will be applicable to Other Backward Classes for 3 years, Scheduled Castes/ Scheduled Tribes for 5 years on the upper age limit.
9. **Application Fee:**
  - **Contract:** The application fee shall be paid online through the payment gateway system provided in the online Application at the rate of **Rs.100/-(Rupees hundred only) for SC/ST category and Rs.250/-(Rupees Two hundred and fifty only) for others.**
  - **Only SC/ST caste categories listed in the Kerala PSC will be considered.** Applicants from other states belonging to SC/ST categories, not listed in the Kerala PSC will be considered as General category.
